#### AGENDA

- 1. Minutes from the January 24th, 1991 city meeting were read. Mike Butler made a motion to approve as read. Adrian Gawlik 2nd the motion. Motion was carried. Minutes from the February 11th, 1991 meeting were read. Adrian Gawlik made a motion to approve as read. Mike Butler 2nd the motion. Motion was carried.
- 2. The Financial report and bills paid for the month of January were read. Adrian Gawlik made a motion to approve as read. Mike Butler 2nd the motion. Motion was carried.
- 3. Ordinance # 022891-1A amending Ordinance # 92889-1A and Ordinance # 042588-1A was read. Mike motioned to approve as read pending approval by Randy Savage, city attorney. Adrian Gawlik 2nd the motion. Motion was carried.
- 4. Discussion on the Animal Ordinance questioned apiaries and the need for a variance or not to have them in the city. It was discussed to not have the city commissioners grant variances each and every time with the ordinance. It was suggested to have apiaries allowed unless a person within close proximity could provide a medical document of allergies to bee stings. The commissioners would give final review to the Ordinance and it would be placed on the next regular city meeting for final approval.
- 5. Adrian Gawlik made a motion to appoint Tom Lasky as city inspector for sewerage systems within the City of Cottonwood Shores. Mike Butler 2nd this motion. Motion was carried.
- 6. Mike Butler made a motion to allocate \$4,500.00 to the Cottonwood Shores Volunteer Fire department for regular maintainance. Adrian Gawlik 2nd the motion. Motion was carried.

Mike Butler made a motion that the city write a letter of support for the fire department with \$3,000.00 to be allocated for the years 1992 and 1993. Adrian Gawlik 2nd the motion. Motion was carried.

- 7. The local sales tax issue was tabled until further information was available to place this on the ballot for the May 4th, 1991 election. A special meeting would be called if this was to be placed on the ballot.
- 8. The hiring of a deputy municipal clerk was tabled until further discussion on this as well as a possible person could be found to be able to work part time.
- 9. Mike Butler made a motion to change the regular city meeting from the 4th Thursday of each month to the 3rd Thursday of each month. Adrian Gawlik 2nd this motion. Motion was carried.
- 10. Leon Upshaw updated the city with the 911 emergency program. Ed Schafer has been replaced by Alice Tipple. It was also noted that the map that the city had given Ed Schafer has been misplaced and we would have to make another if this was not found.

On the purchase of the property for City Hall, all that is needed is a release signed by the seller before we could close the purchase.

Joe Beyer brought to the commissioners attention that an Ordinance may be needed to help with the parking of vehicles on roads and parking of large trucks in the city. Adrian Gawlik suggested that a possible solution for trucks would be a designated area for parking.
