
## AGENDA

The City of Cottonwood Shores Commissioners convened in a Special City Meeting May 9th, 1991 at 7.00 p.m. at City Hall located at 3915 Cottonwood Drive. Those present were Leon Upshaw, Mayor; Adrian Gawlik, Commissioner 1 and Mike Butler, Commissioner 11.

1. Mayor, Leon Upshaw canvassed the Election returns and tally sheets for the General Election of May 4th, 1991. Joseph F. Beyer was elected Mayor with 115 votes. Adrian Gawlik was elected Commissioner 1 with 90 votes. Mike Butler was elected Commissioner 11 with 81 votes.

2. Joseph F. Beyer, Adrian Gawlik, and Mike Butler took the Oath of Office and were therefore officially sworn in to office.


