

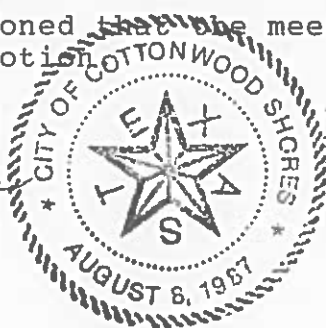
1. The City of Cottonwood Shores received one (1) bid. This bid was received from B.F.I Waste system. It was opened by the City Secretary and the cover letter was read by Joseph Beyer. B.F.I.'s bid for garbage collection on a weekly pickup is \$9.97 per residential unit. It also included (2) four cubic yard containers serviced one time a week for a period of (4) weeks per year. They also met all of the contract specifications asked for by the City of Cottonwood Shores. David Searcy said he would find out if we would need to charge tax on the billing as B.F.I does now on the billing. The city would have to provide a monthly list of all new customers as well as in-active customers. The city will need to notify B.F.I. of the particular holidays that we would allow B.F.I. to pick up on and once the decision is made, B.F.I. will notify all customers. There was talk on the landfill crisis. B.F.I. can offer the city security of our garbage being disposed of whether it is in Burnet or another place due to the size of their company and the area they serve. It was also noted that if the City set up a recycle program, B.F.I. will renegotiate the contract. Mike Butler made a motion to table until the next scheduled city meeting. Adrian Gawlik 2nd the motion. Motion was carried.

2. Mike Butler suggested that some advertising be made for the position of city secretary. It was suggested that we place several flyers and advertisements and place a deadline on the acceptance of resumes to Wednesday at 5.00 p.m., July 17th, 1991. A decision would be made at the regular city meeting, July 18th, 1991 as to who they wish to train for the position.
