### SPECIAL CITY MEETING AND WORKSHOP

May 18, 1995

Mayor Kathy Griffith called the Special City Meeting and Workshop to order at 7:05 p.m.. Commissioner Maugham and Commissioner Gawlik were present and confirmed by roll call.

(a) Mayor Kathy Griffith, Commissioner Patti Maugham, and Commissioner Adrian Gawlik were sworn into office for the May 6, 1995 General Election for their new two year term by City Secretary Teri Hogan.

(b) General discussion led to the decision that the city swimming pool would be open from 3:00 p.m. to 8:00 p.m. Wednesday through Sunday and to be closed Monday and Tuesday. The pool phone number is 693-6467. It was decided that indoor-outdoor carpet should be installed in the entry to the bathrooms and in the bathrooms because it is so slick when it is wet and to contact Mike Lenz about the job and get a bid. It was also decided that the animal permits could be used as the daily passes and that the family season passes could be made on the computer and laminated. Volunteers would be needed to collect the passes and to have swimmers sign a sign-in sheet so the lifeguard could do his job.
