Regular City Meeting August 17, 1995

Mayor Pro-Tem Maugham called the meeting to order at 7:05 p.m.. Present and confirmed by roll call was Commissioner Gawlik. Mayor Griffith was not present for the meeting.

- (a) Minutes for the July 13, 1995 Regular City Meeting and the July 13, 1995 Special City Meeting were motioned to be approved as written by Commissioner Gawlik. Mayor Pro-Tem Maugham seconded the motion. Motion was carried.
- (b) Approval of the Financial Reports for June and July of 1995 were tabled.
- (c) Jo Anne Austin of the Civic Pride of Cottonwood gave a report on the progress of their committee and that they were having a lot of success raising funds for the project in front of City Hall and that a lot of positive spirit was evident from citizens and business owners within the city. It was also noted that donations and donated labor were a big factor in the efforts of these citizens. They requested from the city the use of the Community Center for their meetings due to the size of their group. Mayor Pro-Tem stated for the record that the Mayor has had complaints on allowing the use of the Community Center without a fee when other groups are charged a fee for the use of the center. It was suggested that the Civic Pride hold their meetings prior to the Regular City Meetings. The Civic Pride commented that they had already voted on the dates for their meetings and that these were to be held on the second Monday of each month at 7:00 p.m.. Municipal Judge Leon Upshaw stated that the Civic Pride be allowed to use the Community Center in the spirit of the meetings and for the good of the community.
