**Mayor Maugham called the Public Hearing to order at 7:05 p.m..
Commissioner Gawlik and Commissioner Pfeifer were present and
confirmed by roll call.**

Tony Plumlee of Willis Environmental Engineers presented to the public information about the 1996 TCDP Grant application for \$250,000.00. The application must be in by April 8, 1996. Tony explained that points are given with priority given to water, sewer, and housing needs for 145-175 points. Streets and drainage are 130-150 points. Other needs are less than this. It was discussed that the city water utility is out of compliance with TNRCC regulations and that the greatest need is still the water system. Commissioner Gawlik stated that water/sewer is the cities top priority. Commissioner Pfeifer agreed and stated that the city needs to apply for funds for improvements to the water system. Leon Upshaw stated that we need to finish up improvements to the city water project before the city addresses roads. It was noted that the cities required 5% match brings 60 points. It was suggested that the city contact the Civic Pride group for helping with the new survey.

Meeting adjourned at 7:40 p.m..


