REGULAR CITY MEETING AUGUST 15, 1996

Mayor Maugham called the Regular City Meeting to order at 7:00 p.m. Commissioner Gawlik and Commissioner Pfeifer were present and confirmed by roll call.

(a) Commissioner Pfeifer motioned to approve the July 18, 1996 Regular City Meeting Minutes. Commissioner Gawlik seconded the motion. Motion was carried.

(b) Mayor Maugham introduced Sarah Crawford as the temporary City Clerk until the Commissioners approve her as City Clerk upon the recommendation of Mayor Maugham. Commissioner Gawlik made a motion to hire Sarah Crawford as full time City Clerk barring no complications on the drivers license and criminal history check. Commissioner Pfeifer seconded the motion. Motion was carried.

(c) No action taken due to the failure of Bonnie Morgan to attend the meeting.

(d) Commissioner Pfeifer asked Mayor Maugham why the CD's have not been purchased and that \$400 - \$450 in interest has been lost. Mayor Maugham stated that circumstances have been extenuating. Commissioner Pfeifer stated that he would go with the City Secretary tomorrow and purchase the CD's.

Robert Wilson asked about a traffic light on 2147 and it was explained that the city has no control over the highway. Mayor Maugham was asked about our roads within the city limits and she explained to pave 1 mile would cost \$100,000.

Judge Upshaw brought up the need for volunteers to help patch the roads and it was noted to spend what money is left in road maintenance before the fiscal year is up.

Glenn Henderson brought up the sales tax issue and even if \$300-\$400 is brought in, at least it is some money.

Mayor Maugham brought up that she would like to see the city hire a laborer to patch streets if the budget for next year can handle the expenditure. Mayor Maugham also asked the City Secretary to contact the County Commissioner for our district and see what help the county can provide for the maintenance or repair of the city streets.

Meeting adjourned at 7:34 p.m.
