The City of Cottonwood Shores Commissioners convened in a City Workshop Thursday, May 31st, 1990 at 7.15 p.m.. Those present were Leon Upshaw, Mayor and Mike Butler, Commissioner 11. Also present was Tony Plumlee of Willis Environmental Engineers.

## AGENDA

Agenda #1. Tony Plumlee presented information on financing through the Farmers Home Program on a grant/financing package of either 50% grant and 50% financing or 70% grant and 30% financing. The preliminary grant application will cost \$800.00 payable to Willis Environmental Engineers. Tony said they had scoped out the city and had narrowed down the placement of sewer and water lines needed to service Cottonwood Shores as it is today. The city is grant eligible and we would qualify through the 1980 census. The package includes cost of home connections which can be costly to homeowners. If Farmers Home accepts our preapplication, then we would go through with the final application. Mike Butler made a motion to have Tony Plumlee fill out our preapplication of Farmers Home. Leon Uphsaw 2nd this motion. Motion was carried.


Agenda #2. The discussion or action was tabled due to the ordinances not available at this time. Tony Plumlee had talked to Susan Rocha of T.M.L. and she was sending some updated information on Zoning and Subdivision Ordinances to update the preliminary ones already drawn up.

Agenda #3. Bob McKewin's letter of resignation was accepted. Mike Butler made the motion to accept Bob McKewin's resignation. Leon Upshaw 2nd this motion. Motion was carried. Bill Hannesy introduced Laurie Hoefs as a possible replacement as Municipal Judge of Cottonwood Shores. It was decided to place Laurie Hoefs on the next regular city meeting agenda.

Agenda #4. Leon Uphsaw read letter from Les Witcher of L.C.R.A. Adopt-A-Tract program and the safety guidelines. Leon Upshaw said we would organize a clean up crew in the next month or so.

Meeting adjourned at 8.10 p.m.


