The meeting was called to order by Mayor Kathy Griffith at the Community Center, located at 4111 Cottonwood Drive, Cottonwood Shores, Texas. All members of the City Council were present except Councilman Schwing.

The cost of repairs for opening the pool was discussed. The admission charge was set at \$1.00 for children 3 - 12, and \$1.50 for age 13 and up. No child under the age of 12 can swim without an adult or parent present. Pool hours will be 1:00 - 6:00, Tuesday through Sunday. It will be closed on Monday. Tuesday and Thursday night, from 6:00 to 10:00, will be Family Night. The City will pay Jean and Glenn Bowman to maintain the pool for the season, \$75.00 a week. The City will try and open the pool as soon as possible and be open through Labor Day. The City needs to check on hiring a lifeguard. The swimming pool can be rented for \$50.00 for two hours. The individual renting the pool would have to hire their own lifeguard. Councilor Wilson made a motion to open the pool and authorize the expenditures of the money set aside for opening the pool to spent in a prudent manner. Councilor Smyrl seconded the motion. All - Ayes, 0 - Noes. Motion carried.

The Ordinance No. 052593, Junk Car Ordinance, was read. Councilor Maugham made a motion to approve the Ordinance as amended. Councilor Wilson seconded the motion. 4 - Ayes, 0 - Noes. Motion carried.

Councilor Smyrl made a motion to appoint Leon Upshaw as Municipal Court judge if he would accept the position. Councilor Wilson seconded the motion. 4 - Ayes, 0 - Noes. Motion carried.

Councilor Wilson made a motion to adjourn. Councilor Smyrl seconded the motion.

The meeting was adjourned at 7:50 p.m..
