### PUBLIC HEARING

August 26 1993  
7:05 p.m.

The meeting was called to order by Mayor Kathy Griffith at the Community Center located at 4111 Cottonwood Drive, Cottonwood Shores, Texas. All members of the City Council were present, except for Councilor Jim Smyrl and Councilor Adrian Gawlik, and confirmed by roll call.

The Mayor stated that the hearing was being held to discuss the funding available through the Department of Housing and Community Affairs and to see if the community wanted to apply for more funding.

Tony Plumlee, with Willis Engineering, was present and explained what funding was available this year. He explained the five funding categories. This year's program is very similar to the one last year. The amount of funding available this year has been increased and could possibly fund approximately 10 projects. The matching funds would be the same, which is 5%. The projects with the highest priority would be water, sewer, and housing. Handicapped accessibility was added as a high priority project this year, due to the Americans with Disabilities Act. He stated that the City would only be eligible for the Community Development Block Grant funding. To be more competitive, he strongly advised the City to apply for water and sewer funding.

Claudie Short asked what the chances were for the City getting another grant this year? Tony explained that you have to meet certain thresholds, first the City has recently signed a contract with the State for this program, and the City has recently employed the services of an engineer. You have to meet these thresholds before being eligible for more grants.


Sylvia Lewis asked what the reporting requirements were for the grant we will be receiving? Tony said that he was not familiar with the reporting requirements, but Shirley is to meet with Julie Hartley to set up the administration of the grant, and there are certain procedures that have to be followed. The City will be audited. The records of the meetings will have to be kept on file, along with the attendance record. If the implementation of the grant is not followed, it will hinder our chances of receiving another grant.

Tony also stated that the city has to have two public hearings prior to submitting an application. At the second public hearing it will be decided what the community wishes to apply for. At the next City Council meeting the City has to pass an ordinance that the City wishes to apply for this year's funding program, with the amount included, and what type of funding the City is applying for. The deadline for applications is September 29, 1993. They will be awarding the contracts in January of 1994.

There were no further questions regarding the grant funding. The meeting adjourned at 7:40 p.m.
