> Public Hearing September 9, 1994 7:00 p.m.

The meeting was called to order by Mayor Kathy Griffith at the Community Center, located at 4111 Cottonwood Drive, Cottonwood Shores, Texas. All members of the City Council were present and confirmed by roll call.

The Mayor stated the meeting was being held in regards to the submission of an application for a grant to the Texas Department of Housing and Community Affairs.

Tony Plumlee, Willis Engineering, was present. He stated the amount of the grant we were applying for is \$250,000 and the City would have to have matching funds of 5%, which would be \$12,500. The grant funds would be used to address improvements needed, such as, the increase in water pressure, storage facilities and the transfer pumps at the Water Plant. The City is under a citation at this time and if the City does not respond within the reasonable period of time, the City is subject to a \$500.00 a day fine by TNRCC. We are trying to defer those costs by correcting those problems with this grant.

Sylvia Lewis asked Mr. Plumlee if this new grant would address the problem with the distribution lines. Mr. Plumlee stated that this new grant would be for new 8" transmission line, elevated storage and some fire hydrants.

Mr. Plumlee presented the Council with a set of plans for the improvements. He explained that the City now has an existing 4" single pipe that pumps water from the treatment plant up to a storage tank. That pipe is extremely under-sized. According to TNRCC, that pipe needs to be a minimum of an 8" line to serve the population right now. Along with the new line construction, we propose to put in new transfer pumps and piping equipment at the treatment plant now. The present pumps right now can't handle the gallons per minute required by the state. The proposed storage facility is 16' wide by 80' high. The height and diameter of the storage facility will insure all of the people in the Cottonwood Water System proper pressure throughout the whole system. From the storage facility, we propose to run an 8" line, with appropriate fire hydrants, along Kings Way, along various lot lines on FM 2147, parallel that and continue up and intersect with Cottonwood Drive and run the line down as far as the money will allow. Also included in the grant we have aproposed bore under the highway as well as a number of fire hydrants along the highway. This will at least help us with some fire protection. This is not everything we wanted to accomplish with the grant but, at least its a start.

There was no further discussion regarding the grant application.
