REGULAR MEETING November 10, 1994

The Regular City Council meeting was called to order by Mayor Pro-Tem Patti Maugham at the Community Center, 4111 Cottonwood Drive, Cottonwood Shores, Texas at 7:05 p.m.. All members were present and confirmed by roll call except Mayor Kathy Griffith due to illness of a family member.

Items For Individual Consideration

- (c) Will Martin of Pedernales Electric Cooperative, Inc. discussed that the December bill will have the new rate increase as approved by the Public Utility Commission of Texas. It will be based on the October usage and will be \$6.70 per 1000 kw and subsequent bills will reflect this new PCRF charge.
- (d) Jim Robertson asked the commissioners about the hiring of a licensed operator for the sewer system for the first year and if that was necessary as Bay Maintenance is contracted for the upkeep and maintenance of the sewer system for the first year and that we talk to Willis Environmental Engineers about this matter. The Calculation also raised the question of why the city provides the education needed to become a licensed operator for the water and sewer departments when there is no guarantee that the person trained will stay with the city and why they are not required to pay back the city for the education. The council informed Jim Robertson that if the city had had a qualified applicant apply for the position, they would have been hired and the training of an employee was a necessary procedure. The city does not require the employee to reimburse the city for their education and that there was no way to guarantee that the employee would stay with the city.

 Commissioner Gawlik made a motion to table agenda item (d) regarding the hiring of Milton Dilworth for the Sewer Department until the city could check with Willis Environmental Engineers about this matter.

 Commissioner Maugham seconded the motion. All Ayes, 0 Noes. Motion carried.
- (e) and (f) Commissioner Maugham motioned to table agenda items (e) anf (f) regarding an amendment to the City Budget to move the salary for Milton Dilworth from the Water Department to the Sewer Department and on proposed Ordinance 111094 amending the budget to move salary from the Water Department to the Sewer Department. Commissioner Gawlik seconded the motion. All Ayes, 0 Noes. Motion carried.

(g) Commissioner Maugham read City Secretary/Clerk Shirley Pitts letter of resignation and moved that it be accepted. Commissioner Gawlik seconded the motion. All - Ayes, 0 - Noes. Motion carried.

Commissioner Gawlik motioned the meeting be adjourned. Meeting adjourned at 7:32 p.m..
