#### **REGULAR MEETING**

December 8, 1994

The Regular City Council meeting was called to order by Mayor Kathy Griffith at the Community Center, 4111 Cottonwood Drive, Cottonwood Shores, Texas at 7.03 p.m.. All members of the City Council were present and confirmed by roll call.

#### Consent Agenda

S. . 1.

- (a) Sharon Mullen read Oath of Office and swore in Teri Hogan as City Secretary/Clerk for the City of Cottonwood Shores.
- (b) The November 10th, 1994 Minutes were amended to clarify Chet Altis as raising the question about why the City pays for schooling of employees. Commissioner Gawlik motioned to accept the November 10th, 1994 Minutes as amended. Commissioner Maugham seconded the motion. All Ayes, 0 Noes. Motion carried.

#### Items for Individual Consideration

(c) Tony Plumlee of Willis Environmental Engineering, Inc. presented the City Council with a Contract Change Order #3 construction bid in the amount of \$125,074.00 as the projected cost to install 20 connections for Castle Acres, Castle Terrace, and the Boat Marina to hookup to the City of Cottonwood Shores Sewer System. A map was presented to show the layout, grinder pumps, connections and pipe size needed. The City would be responsible for maintaining the motor unit (grinder pumps) but not the lines that carry the sewage.

Chet Altis asked if the City was going to annex the area if service was going to be provided. Mayor Griffith informed the public that we could not force annexation even though the city would be providing services. The City, however, could adjust the sewer rate to compensate for the cities maintenance of the sewer system for Castle Acres, Castle Terrace, and the Boat Marina. Tony Plumlee explained that surplus funds from the grant would go back to Farmers Home Administration if not used and that we would have a surplus of funds in the amount of \$92,756.00 after hooking up these residents. He also informed the Council that FmHa has allowed for the purchase of a backhoe to maintain the sewer system for other cities and that this could be what the city could do with the surplus grant funds.

Jim Robertson asked if Castle Acres, Castle Terrace, and the Boat Marina would receive the same benefits as the City did in regards to hooking up the sewer at no cost to the homeowner. Tony Plumlee said that the \$125,074.00 included the hookup.

- (d) Commissioner Maugham made a motion for the City of Cottonwood Shores to accept the Contract Change of Order letter and upon approval from Farmers Home Administration, Castle Acres, Castle Terrace, and the Boat Marina would be included into the City of Cottonwood Shores Sewer System. Commissioner Gawlik seconded the motion. All Ayes, 0 Noes. Motion carried.
- (e) Commissioner Maugham made a motion that purchases or orders made for any department for the City of Cottonwood Shores exceeding the cost of \$100.00 have prior approval from the Mayor or Mayor Pro-Tem. Commissioner Gawlik seconded the motion. All Ayes, 0 Noes. Motion carried.
- (f) Commissioner Maugham read an Ordinance regulating the use of the City of Cottonwood Shores Parks and opened the floor to discussion. Commissioner Maugham expressed her concern for the parks with the uncontrolled use of all terrain vehicles, drinking, and general unruliness that occurs and that the kids that are doing this are not residents of the community. Discussion about allowing drinking of alcoholic beverages or to prohibit altogether, keeping non-residents out of the parks, and disturbing the peace enforcement to help control the park use ensued with Jim Robertson making the point that whatever is decided, enforcement has to be done for all and not selective enforcement as was suggested by some. Commissioner Maugham suggested that citizens could leave suggestions at the City Hall. Commissioner Maugham moved that the item be tabled for now.
- (g) A Christmas Open House will be held December 23rd, 1994 from 1:00 p.m. to 5:00 p.m. at the City Hall. Notice of the Open House will be posted at Bob's Grocery and the City Hall.
- (h) Commissioner Maugham motioned that Shirley Pitts be removed from the Marble Falls Bank signature cards and to place Teri Hogan, City Secretary/Clerk for the City of Cottonwood Shores on the signature cards for the following accounts;

Interest and Sinking Fund account

Water Deposit account

Commissioner Gawlik seconded the motion. All - Ayes, 0 - Noes. Motion carried.

- (i) The Closed Executive Meeting was tabled and will be held December 13th, 1994 at 7.00 p.m..
- (j) No action taken as the Closed Executive Meeting was tabled.

- (k) Mayor Griffith asked that Fred Hisey be contacted to fix the leaks that occur on the Community Center wall facing Oak Lane.
- (l) Commissioner Maugham made a motion to comply with the Americans with Disabilities Act. Commissioner Gawlik seconded the motion. All Ayes, o Noes. Motion carried.
