### EMERGENCY MEETING March 7, 1995

Mayor Kathy Griffith called to order an Emergency Meeting at 7.00 p.m.. Commissioner Maugham and Commissioner Gawlik were present and confirmed by roll call.

(a) There was concern of the council that homeowners within the LCRA jurisdiction were not being informed of the need to have their septic tanks pumped and filled as required by LCRA and that if this was not done, the homeowner would have to bear the cost to have this done once LCRA inspects them. Frank King stated that his crew would make one more contact with the homeowners and that would be it. It was agreed that Milton and Teri would help contact and make arrangements to help the crew finish this.

Adrian Gawlik asked where does the sewage go when the tanks are pumped out. Frank King said that it is being pumped into lift stations and then onto Horseshoe Bay. Adrian wanted to know why this is being done. Frank stated "was this hurting anything?" Adrian stated that the extra volume was not what the city should be paying for.

Kathy Griffith wanted to know what affect this was having on our lift stations and that the city was absorbing the cost of the extra volume being pumped into MUD.


Frank then stated that Willis Engineering gave Bay Maintenance permission to dispose of the sewage into the lift stations.


Milton's concern was the wear and tear on the lift stations.

Frank was not happy and stated that if we mess with him, then the city has made a mistake. He specifically asked Willis and was told to use the lift station as well as the clean outs to pump sewage into.
