SPECIAL CITY MEETING APRIL 15, 1996 5:00 P.M.


Mayor Maugham called the Special City Meeting to order at 5:00 p.m.. Commissioner Gawlik and Commissioner Pfeifer were present and confirmed by roll call.

(a) The first bid opened for a backhoe was from Kuenstler and for a 1993 John Deere is \$33,800.00 and for a 1994 John Deere is \$38,450.00 with a three day delivery. The second bid for a backhoe was from Holt for a 1994 Caterpillar for \$31,900.00 with a 10 - 20 day delivery. Commissioner Pfeifer noted that the Holt machine could extend 3' 6" for a total of 18' 2" digging depth and that it had a warranty on the power train until August 1997. Commissioner Pfeifer motioned to award the purchase of a backhoe to Holt for the 1994 Caterpillar for \$31,900.00. Commissioner Gawlik seconded the motion. Motion was carried.

(b) The first bid opened for the Sewer Cleanout Machine was from Underground for a Pipe Hunter for \$19,900.00. The second bid opening was from Montgomery Supply for a Shamrock for \$18,743.00. The third bid was from AEW Sales for a Model 747 for \$18,150.00. It was noted that all had close to the same working pressure, same length of hose and the tank capacity about the same. Commissioner Gawlik motioned to award the bid for purchase of a sewer cleanout machine to AEW Sales with the low bid of \$18,150.00. Commissioner Pfeifer seconded the motion. Motion was carried.

Meeting adjourned at 5:31 p.m.
