City Administrator/City Secretary Sheila Moore announced that a quorum was present.

### 4. Financial Workshop and Budget Review

Financial Officer Orr stated that the Council would use the information presented as a kick off for next year's budget. He told Council and the audience that the City of Cottonwood Shores <u>must</u> grow. The largest problem areas for the City in the future are - World: Greece, China and Extremism; Nation: oil prices, Congress and Extremism; State: the drought, oil prices, property/school taxes, basic State finance model and the Business Climate; Local: trickle down from State Financial model problems, ability to capitalize on available growth and City funding sources.

The problems that the City of Cottonwood Shores MUST solve in order for it to grow are: roads, wastewater, antiquated water system; public safety and image.

He then went on to present his recommendation for amending the budget.

limited to 3 minutes after they have been acknowledged to speak by the chair of the meeting. If the Citizen wishes to make comments about an item that is already on the agenda, discussion will be deferred until the item comes up.

Wendy Wayson spoke to acknowledge the City's police officers during this transitional time. Their visibility is appreciated and makes her feel safer. She said Interim Chief Bieze and Officers Talamantez and Dodd are courteous and respond in a concerned manner.

John and Billie Parker left a comment that the Mayor read for them regarding the non-enforcement of the Sound Ordinance as it pertained to On The Rocks' extremely loud music several nights a week.

### 6. Mayor's Report: No Report

City Administrator reported that Dollar General's signs were up and the lights were on; scheduled to open on May 18. She also reported that Interim Chief Bieze had secured a non-paid reserve officer who will be worked into the schedule as needed along with Officers Talamantez, Dodd and himself.

Parks and Recreation Board Chairman Ray Whitis reported on the Parks. Boat ramp is up and running and well used. One issue to address is when boaters back onto the ramp at night there have been problems with slipping off the edge of the ramp. The Playscape at community park needs to be repaired and the fence around the basketball court are being worked on. Working on stepping up security at the parks in conjunction with the Crime, Control and Prevention Board. At their next scheduled meeting, they will be discussing the Nature Reserve and Bike Trail.

9.3. Discussed and considered action on activating the Splash Pad at Community Park. As requested by the Parks & Recreation Commission.

Parks Commissioner Wendy Wayson requested that the Splash Pad be opened from Memorial Day through Labor Day this Summer. It was a big hit last year and the children really enjoy and need it. She recommended running it on Saturdays from 11:00am to 3:00pm.

9.4. Discussed and reviewed ADA Plan for Noah Thompson Park. As requested by the Parks & Recreation Commission.

Parks Commission Chair Ray Whitis presented the Park's recommendation. Acknowledged there were some grading issues and they chose to place the ADA picnic table where the least grading work would be needed. Grant Administrator Cummings let them know that she had already sent their plan to TPW who had approved it and now needs to submit the plans to TDLR and send TPW the TDLR registration number to ensure compliance with accessibility standards. After ADA is complete on all the parks, will begin working on original plan designs.

9.5. Discussed and reviewed options for tires at P-Squared Park. As requested by the Parks & Recreation Commission.

## ORIGINAL

Parks Commission Chair Ray Whitis began the discussion by posing the question if the tire problem was an environmental issue, health issue or an aesthetic issue. It has been that way for 5 years and the BMX trail has had zero usage in that time. Councilmember Porter said that it is not being used because it has not been finished. And that the state/grant paid for the BMX park with the skate park attached, not the other way around. Cannot just eliminate the BMX park. More research would need to be done on that issue. Ray said that it will cost the City either way (removal of tires or completion). Ray had done some research and quoted from the Texas Administrative Code and from TCEQ his discovery that the tires in their current status were now a legal issue. The City is in violation of the law which turns the problem into a tire extraction issue.

Jim Bristow had met with a person from Reliable Tire Disposal who came out and reviewed the tires. He quoted a price of \$3.00 per tire plus \$60 per hour to remove and dispose of all the tires. Burying the tires was not a feasible solution due to the sheer number of tires and the amount of work required to cut the tires before burying them. Debbie Holloway spoke with Commissioner Dockery who said he was aware of the problem and that perhaps the County could help. Chair Whitis said he would pursue the issue further with Commissioner Dockery to see what could be done.

City Administrator Moore answered Chairman Whitis' question posed at the beginning of the discussion: if the tires were an environmental issue, health issue or an aesthetic issue. She said it was all of those, plus the added problem that the park had now become a dumping ground for tires which only exacerbated the issue.

It was agreed that the Parks Commission would come back to Council with a recommendation on what they feel the Council should decide to do on the tires.
