### 5. Presentation of the Granite Shoals Deer Management Program.

Jody Macek presented information to the City Council and audience in regards to the Deer Management Program that the City of Granite Shoals has been utilizing to help with the over population of deer. He informed the City Council that this process would take approximately 2 years to obtain through the State of Texas, Parks and Wildlife. He covered the process of collecting the animals and their licensing of the hunters. He addressed the procedures in disposing of the animals taken by giving the meat to various nonprofit charities as well as individuals in need of food.

This project helped to reduce the population in Granite Shoals drastically. After the surveys and observations performed approximately 78 animals were taken.

It was indicate that approximately 10 acres of land would supply the needs for 1 deer.

Mr. Macek presented the City Council with a packet to help them in the process of obtaining this program if they so choose.
