## 7.3. Discussed possible grant opportunities. As presented by Gandolf Burrus

Mayor Orr opened the item for discussion and turned topic over to Gandolf Burrus for his presentation for upcoming grants that the City of Cottonwood Shores may have an option to obtain.

Mr. Burrus stated he has been working with the city for approximately 30 years.

He stated there were two grants out there, 1 major one from TexDot known as a Transportation Alternative or TA grant which could be utilized for multiple improvement projects such as sidewalks, drainage, etc. This grant is a 20% percent match grant with no upper limit.

To qualify for this a sidewalk or something needs to connect to a TexDot Roadway.

There is also a local LETS

There is also a fire truck grant which is a 5% match.

Some items discussed included a need to loop water lines in the main portion and also the Castle Terrace area of the city.

Another was the need to construct or build a new grinder pump lift station in the western portion of the City.

A need for this item to be brought back to the City was mentioned.

Mayor Orr pointed out to the City Council the current buyout or lease on the machine currently in place at City hall. He commented that the machine was beginning to have several issues and the contract and maintenance agreement had expired. The cost analysis of keeping the existing machine versus a new contract with a new machine was presented. The new machine would actually cost the City approximately \$9.00 less per month.
