8. **New Business**

8.1. **Discussed and considered action on amending Ordinance 4005 (Garage Sales). *As requested by Staff***

City Administrator / City Secretary Sheila C. Moore opened explaining the premise as to why the city should amend the ordinance. She showed the state tax laws regarding this type of businesses or events. The law states that if anyone has more than two garage sales in a 12-month period they would be considered running a business and would be required to collect and pay sales tax. In the event of them being a non-profit, they would still have to collect sales taxes on items or merchandise they sell.

Councilmember Wayson stated the changes in the ordinance was quoted from state law which he agreed, however he did have a couple of items he would like to see changed, removed or added.

8.2. **Discussed and considered action on approving the purchase of a new phone system from Frontier Communications for City Hall and the Police Department. *As requested by Staff.***

Mayor Orr opened discussion and spoke on the financial portion of obtaining funding of a new phone system. He commented that the monies could be utilized from two separate sources. First, the city received a refund check of approximately \$8,000.00 from Republic Services which were held for this type of improvement and second, the Crime Control Prevention District approved funding of \$3,000.00 towards the new system at the police department. The total cost of the system will be approximately \$15,000.00. The city would only have to fund an additional \$5,000.00. It was mentioned that some of the INS funds could possibly be available.

Councilmember Wayson questioned a portion of the service contract referring to who actually owned the system Frontier or the City?

It was asked if the system was current and was acknowledged it would be state of the art.

Councilmember Wayson stated although the system seemed reasonable he believed the cost of the phones seemed high. It was explained that there were approximately 12 to 14 phones being purchased.

Police Chief Liendo commented that the system he is utilizing at the police department currently is very outdated, obsolete and even substandard.

Michael Hibdon asked if the service agreement provided for upgrades. This was unknown but would be addressed before signing.

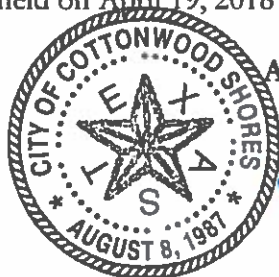

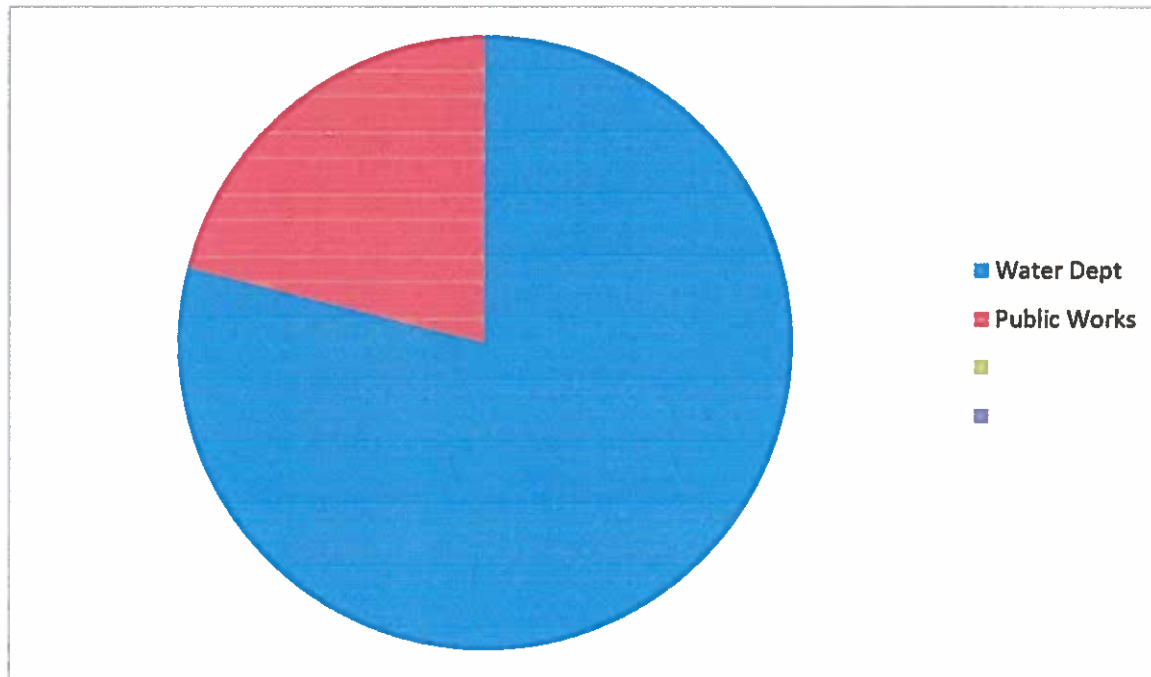

Monthly Activity Report March 2018

We didn't open any new cases during the Month of March but we managed to close two of the remaining seven cases leaving a total of five still under investigation.

We completed our Junk Vehicle survey identifying the remaining vehicles that are still in violation of ordinance 12002. We had previously identified approximately 36 violations. Written warnings were given to violators and to date it appears that 13 citations will be issued. I feel that this project has had some success, feel confident that we will continue to monitor this issue.

Officer Padraza, and myself completed state mandatory court security training and Legal update classes concerning new state laws.

During the month of March the department acquired a membership to the Copper Creek Shooting Club. Our officers are required by the state to qualify our duty weapons once or twice a year this membership will allow us to meet that standard. In the past we had to request permission from agencies to allow us the use of their range facilities. This membership gives us the opportunity to train and qualify our officers at our own convenience.
