We didn't open any new cases during the Month of April but we managed to close one of the remaining five cases leaving a total of four still under investigation.

Of the 13 junk car citations needing issuance 4 were issued and 9 complied. We continue to experience compliance to the warnings which were previously issued. Once again as I have mentioned this project will continue throughout the year. During the month we began focusing on code enforcement issues that have plagued our tenant population. We are researching a Habitability Ordinance that will address these issues, which we hope to introduce within the next 30 days. Also we are going to have an Animal Control Officer vacancy beginning in May. Cameron will be leaving the department for greener pastures we also wish him well.
