Citizen – Wendy Wayson, addressed some problems occurring in the parks. She advised that someone has been discarding empty containers and wrappers in the parks and alongside the city streets. She suggested the installation of cameras at the parks may help to locate the perpetrators.

She also showed a picture from *The Highlander* Newspaper of the new play scape swing that was installed at Community Park by the Parks and Recreation Committee along with multiple volunteers and commented on the good press coverage for the City.

Citizen – Jean Langendorf, addressed the council with her concerns towards the paving of the streets. She indicated that at the intersection of Birch and Brookwood there were dips or swales in the roadway making it very difficult to cross. She stated that this was extremely sloppy work on the streets. Stated there seemed to be no or very little base within the lower end or 800 block.

Citizen – Sylvia Breen, commented that some of the agenda items seemed to be backwards on the agenda and may need to be reversed.

Mayor Orr did not have a report.

Parks and Recreation Committee president Sylvia Breen presented a report on the new swing set that was installed in Community Park. She stated that there were already children utilizing the equipment.

Councilmember Wayson asked if the Chief is an officer of the city and the mayor agreed that he was due to the City does not have a Marshall.

Mayor Pro Tem Sherry made a motion stating the Mayor was in violation and asked him to relinquish control of the gavel.

The motion was seconded by Councilmember Satsky.

Citizen – Jim Bristow commented on the issue at hand stating that the dog was indeed a tool and did the council vote on how the radar, body cams and firearms were to be used. He asked if the council approved those and was answered yes, in the Police Policy and Procedures.

Mayor Orr said the SOP is not a Personnel policy.

Councilmember Wayson stated that the definition of a SOP is a "standard" way of doing things or a common task and a common way to do it. He felt this was not a "common" task.

Mayor Orr stated that he would not ask the Council if the City can enforce the law and he was not going to allow the Council to discuss and vote on this.

Mayor Pro Tem Sherry then stated that was all he needed to hear and the Mayor now has his fat fiefdom and walked out of the meeting at 7:05 p.m.

Citizen – Jean Langendorf commented on the SOP mentioning several new employee titles, which were personnel, so it could be called a personnel policy.

Mayor Orr stated that he would defer this to the next meeting. He said if the council wants to put an item on the next meeting's agenda approving the policy, they had the right to do that, but if they did, it would be without him.

Citizen – Wendy Wayson asked if the city needed a narcotic dog.

Councilmember Satsky stated that the city should let someone else furnish the dog.

Citizen – John Marr commented the fire department had an SOP for everything that were not voted on, Councilmember Wayson stated the dog was actually not the topic.

Councilmember Wayson walked out of the meeting at 7:18 p.m.
