3. Discussed Development

Mayor Orr opened the discussion on development issues within the City of Cottonwood Shores. Within the discussion comments on the development on Thanksgiving Mountain regarding annexation and zoning both past and present were covered. The City Council also discussed the history of this area as well.

4. Budget Workshop

Mayor Orr presented to the City Council information regarding the possibility of moving funds out of the reserve towards allocated projects.

The Parks and Recreation Committee budget was discussed and the amount of monies they were requesting from the City. The Parks and Recreation Committee did not present a request or submit an actual budget. In the budget there was allocations for \$12,000 dollars. After discussion it was decided to

The Cottonwood Shores Volunteer Fire Department requested an increase within their contract of \$4,000.00 dollars. This would make the total of \$34,000.00 for the year.

The City Council decided not to increase the Cottonwood Shores Volunteer Fire Department monies and to maintain the amount from the 2017-2018 physical year.
