REQUEST FOR DRIVING SAFETY COURSE

NOW COMES THE Defendant in the above numbered case and requests that the Court defer all proceedings in this matter for 90 days and that he/she be permitted to attend a Drivers Safety Course approved by the Texas Education Agency (T.E.A.).

1. The Defendant represents the following to the Court:

- a. I have not attended any Drivers Safety Course during the last 12 months for the purpose of having a ticket dismissed.
- b. I am not now in the process of taking a Drivers Safety Course for the dismissal of a ticket.
- c. I have a valid Texas Driver's License or permit to operate a motor vehicle.
- d. I have attached a copy of my proof of financial responsibility (insurance) showing that I am a covered driver.
- e. I have attached a copy of my valid Texas Driver's License.
- f. I do not have a Texas Commercial Driver's License.

2. I understand that within 90 days from this date I must;

- a. Complete the Drivers Safety Course;
- b. Present to the Court the original certificate (Court Copy)(signed by defendant) showing completion of the course and;
- c. Present a copy of my driving record to the court **(form 3A)**.

3. I understand that if I do not comply with the above conditions;

- a. I will be required to attend a show cause hearing and I will be required to show cause why I did not comply with the Judge's order.
- b. A final judgment will be ordered against me and
- c. A warrant will be issued for my arrest with additional costs and fees.

4. I plead (Guilty) or (No Contest) to the offense. (Circle One)

- a. I understand I must remit payment to the court of \$109.10 (\$134.10 in school zone) on or before my due date on the order to appear.
