ORDINANCE 1116

AN ORDINANCE CANVASSING THE RETURNS OF AN
ELECTION OF THREE (3) COUNCILPERSONS FOR FULL TERM

History: December 6, 2012 – Repealed Ordinance 0151806 and Adopted Ordinance 1116

WHEREAS, an election was held at the Burnet County Courthouse Annex, 810 Steve Hawkins Parkway, Marble Falls, Texas for the City of Cottonwood Shores, Texas on May 13, 2006 for the purpose of the election of three (3) Councilpersons for full term; and

WHEREAS, the Council has reviewed and investigated all matters pertaining to this election, including the ordering, notices, election officers, holding the returns thereof; and

WHEREAS, the Council hereby canvasses the returns of this election, at which there was submitted to all resident, qualified electors of the City for their action thereupon, the election of three (3) Councilpersons for full term; and

WHEREAS, the City has diligently inquired into the poll lists and the official election returns which were duly and lawfully made to this Council by the judges and clerks holding and conducting the election; the poll lists and the official election returns showing separately the votes cast in the election; and

WHEREAS, from these returns, this Council hereby finds that the following votes were cast in the election by voters who were resident, qualified electors of the City; and

WHEREAS, each of the candidates in said election received the following votes:


THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COTTONWOOD SHORES THAT:

SECTION 1. The City Council officially finds, determines, and declares that the election was duly and properly ordered, that proper legal notice of such election was duly given in the English language and the Spanish language, the proper election officers were duly appointed prior to the election, that the election was duly and legally held, that all resident, qualified electors of the City were permitted to vote at the election, and due returns of the results of the election had been made and delivered, and that the City of Cottonwood Shores has duly canvassed such returns, all in accordance with the laws of the State of Texas and of the United States of America and the resolution calling the election.

SECTION 2. The following persons are therefore elected as City Councilpersons of the City of Cottonwood Shores for a term of two (2) years:


