ORDINANCE 1120

AN ORDINANCE CANVASSING THE RETURNS OF A SPECIAL ELECTION FOR THE PURPOSE OF REAUTHORIZING A LOCAL SALES AND USE TAX IN THE CITY OF COTTONWOOD SHORES, TEXAS, AT THE RATE OF ONE-FOURTH (1/4TH) OF ONE PERCENT (1%) TO CONTINUE PROVIDING REVENUE FOR MAINTENANCE AND REPAIR OF MUNICIPAL STREETS

WHEREAS, a special election was held at the Burnet County Courthouse Annex, 810 Steve Hawkins Parkway, Marble Falls, Texas, for the City of Cottonwood Shores, Texas on May 11, 2013 (the "Election") for the purpose of reauthorizing a local sales and use tax in the City of Cottonwood Shores, Texas, at the rate of one-fourth (1/4th) of one percent (1%) to continue providing revenue for maintenance and repair of municipal streets; and

WHEREAS, the City Council of the City of Cottonwood Shores, Texas (the "Council") has reviewed and investigated all matters pertaining to the Election, including the ordering, notices, Election officers, holding the returns thereof; and

WHEREAS, the Council hereby canvasses the returns of the Election, which was submitted to all residents; and

WHEREAS, the City has diligently inquired into the poll lists and the official Election returns which were duly and lawfully provided this Council by the judges and clerks holding and conducting the Election; the poll lists and the official Election returns showing separately the votes cast in the Election; and

WHEREAS, from these returns, this Council hereby finds that the following votes were cast in the Election by voters who were resident, qualified electors of the City; and

WHEREAS, the official returns of said election have been delivered to the presiding officer of the canvassing authority and have been certified to the Council by the presiding judge of said election.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COTTONWOOD SHORES THAT:

SECTION 1: The Council officially finds, determines, and declares that the Election was duly and properly ordered; the proper Election officers were duly appointed prior to the Election; that the Election was duly and legally held; that all resident, qualified electors of the City were permitted to vote at the Election; due returns of the results of the Election had been made and delivered; and that the Council has duly canvassed such returns, all in



accordance with the laws of the State of Texas and of the United States of America and the calling of the Election.

SECTION 2: It is hereby found and declared that at the Election described in the preamble hereto there were 192 total votes cast for the Election of continuing the local sales and use tax in the City of Cottonwood Shores, Texas, for maintenance and repair of municipal streets, with 127 cast by early voting, 65 cast by election day voting, and that said ballots were cast as following in the number of votes indicated:

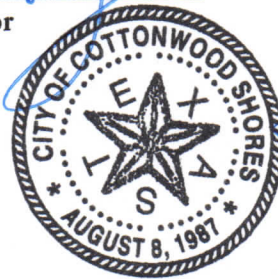
FOR	155 votes
AGAINST	34 votes


