ORDINANCE 11054

**AN ORDINANCE OF THE CITY OF COTTONWOOD SHORES, TEXAS, LEVYING TAXES FOR THE USE AND SUPPORT OF THE MUNICIPAL GOVERNMENT OF THE CITY OF COTTONWOOD SHORES, TEXAS, FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 1995, AND ENDING SEPTEMBER 30, 1996; PROVIDING PENALTY AND INTEREST FOR DELINQUENT TAXES; PROVIDING FOR THE COLLECTION OF DELINQUENT TAXES; AND DECLARING AN EFFECTIVE DATE.**

**WHEREAS;** it is necessary at this time, that said ordinance be passed levying taxes on all property, both real and personal, within the City of Cottonwood Shores, Texas, for the use and support of the municipal government of the City of Cottonwood Shores, Texas, and all requirements of the State of Texas law have been complied with;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COTTONWOOD SHORES, TEXAS, AS FOLLOWS:**

**Section 1:** There is hereby levied, and there shall be collected for the use and support of the municipal government of the City of Cottonwood Shores, Texas, for the year 1995 upon all property, whether real, personal or mixed, within the corporate limits of the City of Cottonwood Shores, Texas, subject to taxation for the year 1995, a tax at the rate of \$.3206 Dollar on each One Hundred and No/100 Dollar (\$100.00) valuation of property to be assessed and collected for the purpose hereinafter stipulated to-wit.

(1) For the maintenance and support of the general government (General Fund), \$0.235 on each One Hundred Dollar (\$100.00) valuation of property, and

(2) For the Interest and Sinking Fund, \$0.0856 on each One Hundred Dollar (\$100.00) valuation of property.

**Section 2:** Taxes levied under this ordinance shall become due October 1, 1995 and if not paid on, or before January 31, 1996, shall immediately become delinquent.

**Section 3:** All taxes shall become a lien upon property which assessed, and the City Assessor and Collector of the City of Cottonwood Shores is hereby authorized and empowered to enforce the collection of such taxes according to the Constitution and laws of the State of Texas, and ordinances of the City of Cottonwood Shores shall, by virtue of the tax rolls, fix and establish a lien by levying upon such property, whether real or personal, for the payment of said taxes, penalty and interest, and the taxes, and interest and penalty collected from such delinquent taxes, shall be apportioned to the general fund of the City of Cottonwood Shores. All delinquent taxes shall bear interest from the date of delinquency at the rate prescribed by law.

**Section 4:** This ordinance shall take effect and be in force from and after its passage.
