**ORDINANCE 11058**

**AN ORDINANCE AMENDING ORDINANCE 093093 BY INCREASING FUNDS INTO THE WATER SYSTEM BUDGET FOR REVENUE ESTIMATES UNFORESEEN AT TIME OF 1993-1994 BUDGET ADOPTION; INCREASING CERTAIN APPROPRIATIONS FOR EXPENDITURES IN THE WATER SYSTEM BUDGET FOR REFUNDS OF WATER DEPOSITS; DECREASING ESTIMATED EXPENSES FOR CERTAIN WATER SYSTEM BUDGETS AND ESTABLISHING A LINE ITEM FOR DUES AND PUBLICATIONS; INCREASING CERTAIN APPROPRIATIONS FOR UNFORESEEN EXPENDITURES IN THE WATER SYSTEM BUDGET FOR FISCAL YEAR 1993-1994.**

**WHEREAS**, the Budget for the City of Cottonwood Shores, Texas for the fiscal year 1993-1994 has heretofore been approved as provided by law; and

**WHEREAS**, unusual and unforeseen conditions have arisen which could not by reasonably diligent thought have been included nor considered prior to or at the time of the adoption of said Budget as aforesaid; and

**WHEREAS**, public necessity has arisen requiring the amendment to said Budget;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COTTONWOOD SHORES, TEXAS:**


That the City Secretary is hereby authorized and directed to file this Amendment to the original Budget, and to make it a part of, by attachment thereto, of the Original Budget, increasing the Water Fund revenues by \$4,600; decreasing Water Fund line item Machine Rentals to \$900; budgeting for line item in Water Fund for Dues & Publications (\$200); budgeting for a line item in Water Fund for Water Deposit Refunds (\$500); estimated expenses for Schools in the Water Fund will not change, but will include one Sewer School.

Income source and expenditure appropriation attachments are an integral part of this Ordinance.
