**ORDINANCE 11072**

**AN ORDINANCE MAKING APPROPRIATIONS FOR THE SUPPORT OF THE CITY OF CITY OF COTTONWOOD SHORES, TEXAS FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2007 AND ENDING SEPTEMBER 30, 2008; APPROPRIATING MONEY TO A SINKING FUND TO PAY INTEREST AND PRINCIPAL ON THE CITY'S INDEBTEDNESS; AND ADOPTING THE ANNUAL BUDGET OF THE CITY OF COTTONWOOD SHORES FOR THE 2007-2008 FISCAL YEAR.**

**WHEREAS**, the budget appended here as Exhibit A for the fiscal year beginning October 1, 2007 and ending September 30, 2008 was duly presented to the City Council by Mayor Sylvia H. Breen and a public hearing was ordered by the City Council a public notice of said hearing was caused to be given by the City Council and a public notice of said hearing was caused to be given by the City Council and said notice was published in the River City Tribune and said public hearing was held according to said notice;

**NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COTTONWOOD SHORES:**

**SECTION 1.** That the appropriations for the fiscal year beginning October 1, 2007 and ending September 30, 2008, for the support of the general government of the City of Cottonwood Shores, Texas be fixed and determined for said terms in accordance with the expenditures shown in the City's Fiscal Year 2007-2008 Budget a copy of which is appended hereto as Exhibit A;

**SECTION 2.** That the Budget, as shown in words and figures in Exhibit A is hereby approved in all respects and adopted as the City's Budget for the fiscal year beginning October 1, 2007 and ending September 30, 2008.

**SECTION 3.** That there is hereby appropriated the amount shown in said budget necessary to provide for a sinking fund for the payment of the principal and interest and the retirement of the bonded debt requirements of the Fiscal 2007-2008 year of the City of Cottonwood Shores, Texas.
