ORDINANCE 12006

AN ORDINANCE OF THE CITY OF COTTONWOOD SHORES, TEXAS AMENDING AND MANDATING THE MAXIMUM SPEED LIMIT OF 25 MPH UPON CITY MAINTAINED STREETS AND ROADWAYS WITHIN THE CITY LIMITS; AUTHORIZING AND DIRECTING THE INSTALLATION, PLACEMENT AND ERECTION OF TRAFFIC REGULATION SIGNS; RATIFYING AND CONFIRMING THE ORIGINAL PLACEMENT AND ENFORCEMENT OF SUCH TRAFFIC REGULATION SIGNS AND DEVICES; MAKING FINDINGS OF FACT; AND PROVIDING PENALTY, SEVERABILITY, OPEN MEETINGS AND PUBLICATION CLAUSES.

February 8, 2018 – Amended speed limits to 25 mph on all City maintained streets, roadways and right-of-ways within the City Limits.

Whereas, the regulation of traffic, motor vehicles and conveyances upon all public streets, roadways and right-of-ways within the City Limits is essential and necessary to protect the traveling public and to preserve and protect the public safety of the City of Cottonwood Shores, Texas (the "City");

Whereas, Texas Transportation Code § 545.352 (b) (1) establishes the prima facie speed limit for urban districts streets at a maximum speed of 30 miles per hour;

Whereas, the operation of vehicles upon the unimproved streets or roadways within an urban district within the City Limits at the prima facie speed of 30 miles per hour would be unreasonable and imprudent given the design, construction and layout of streets, roadways and right-of-ways within the City Limits and residential nature of the City; and

Whereas, after review, inquiry and the opportunity for citizens participation, the City Council has found that urban district streets and roadways within the City should have traffic regulation signs and devices posting the maximum speed limit of 25 miles per hour on all City maintained streets, roadways and right-of-ways within the City Limits.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF COTTONWOOD SHORES, TEXAS, THAT:

Section 1. Findings. The recitations hereinabove are found to be true and correct, are incorporated herein as findings of fact.

Section 2. Ratification and Confirmation. The installation, placement, erection, and enforcement of the traffic regulation signs and devices setting the maximum speed limit at 25 miles per hour for all streets and roads within urban districts of the City is hereby confirmed and ratified by the City Council.

Section 3. Speed Regulation Signs and Devices. The City Council hereby orders and directs that traffic regulation signs and devices be placed, installed and erected at the locations and areas sufficient to provide notice of the 25 miles per hour maximum speed limit on all roads, and that each such sign and device be hereafter maintained and enforced by the City.

Section 4. Speed Limit and Regulation. The City Council hereby adopts the 25 miles per hour maximum speed limit for all public streets and roadways within the City limits that are

urban districts as that term is defined in the Texas Transportation Code § 545.352 (d) (3). Therefore, it shall be unlawful for any person to drive or operate a motor vehicle upon any street or roadway within the City Limits at a speed of greater than 25 miles per hour. Further, it shall be unlawful for any person to operate or drive a motor vehicle upon any street, roadway or right-of-way within the City Limits, which is not in compliance with the law, rules and requirements of the State of Texas and the City Ordinances.

Section 5. Damage to Public Property. It shall be illegal for any person to knowingly or intentionally damage public streets, roadways or any sign posted by the City for regulation of traffic. Any person who knowingly, intentionally or recklessly causes damage to public streets, roadways or any sign posted thereon for the regulation of traffic shall be responsible for the costs of repair or replacement.


Section 6. Penalties. This ordinance shall be enforced by all law enforcement officers of the City of Cottonwood Shores, on all shifts. Officers shall cite any vehicle traveling over 25 miles per hour on any street within the City Limits and shall be deemed guilty of an offense and upon conviction shall be punished by fines and penalties as assessed by the Municipal Court. Each violation shall be deemed a separate offense, and shall be punished accordingly; however, additional compliance may be further sought through injunctive relief in the District Court.

Section 7. Severability. It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses, and phrases of this Ordinance are severable and, if any phrase, sentence, paragraph, or section of this Ordinance should be declared invalid by the final judgment or decree of any court of competent jurisdiction, such invalidity shall not affect any of the remaining phrases, clauses, sentences, paragraphs, and sections of this Ordinance, since the same would have been enacted by the City Council without the incorporation in this Ordinance of any such invalid phrase, clause, sentence, paragraph, or section. If any provision of this Ordinance shall be adjudged by a court of competent jurisdiction to be invalid, the invalidity shall not affect other provisions or applications of this Ordinance which can be given effect without the invalid provision, and to this end the provisions of this Ordinance are declared to be severable.

Section 8. Open Meetings. It is hereby officially found and determined that the meeting at which this Ordinance was passed was open to the public, and public notice of the time, place and purpose of said meeting was given, as required by the *Open Meetings Act, Chapter 551, Texas Government Code*.

Section 9. Publication. This Ordinance shall take effect and be in full force ten (10) days after the publication of the caption hereof in the manner required by law.

PASSED AND APPROVED BY THE CITY COUNCIL OF COTTONWOOD SHORES, TEXAS, AT A MEETING ON THE 8TH DAY OF FEBRUARY, 2018 WITH 3 VOTES IN FAVOR, 0 VOTES AGAINST AND 0 ABSTENTIONS.
