#### 7. Old Business:

7.1 Discussed and reviewed status of all parks. As requested by Chairperson Whitis.

#### **ASPEN PARK:**

Alternate Montgomery informed the commission that Mike, Jim and her assisted in the moving of the tube back at aspen park.

It was mentioned the new playscape is already in need of repair.

The bridge needs to be repaired

Chair Whitis and Vice Chair Holloway indicated they have a way to repair some of the equipment. They also stated the necessity to expand the existing playscape and accomplish more modifications in the park. Vice Chair Holloway indicated the need to do some redesign and planning. Commissioner Wayson stated it looked like he had accomplished that and just needs to continue with the project. Commissioner Wayson stated there was a new method of removal of sand burs with a roller device. It costs about \$75.00 for a small roller, hand operated or about \$450.00 for a larger one that goes behind a tractor. It was discussed there also may be a possibility of rental to the citizens of the city. The volunteers will work this Saturday at the park from about 10:00 to1:00 or 2 to 3 hours. Chair Whitis indicated the need to still install the fence and he had inventoried the materials he already had and decided more parts may be required.

The soccer nets need some attention in the near future.

### **BOAT RAMP:**

There could be a need to place a couple of benches at the boat ramp but not tables.

#### **NOAH THOMPSON:**

Commissioner Wayson stated the sign at the park needs some work. Chair Whitis suggested checking on the ADA needs or requirements.

It was determined this park needs to be completed

## **P-SQUARED PARK:**

ADA requirements were addressed and need to be maintained until completion of the park is obtained.

It was discussed that some benches and tables had been stored at the park.

The berms need to be constructed for the BMX.

The topsoil that someone dumped in the park needs to be removed

### **NATURE PRESERVE:**

Needs some major clean up and possibly some cameras installed for security. It was determined that this could not be an ADA Park due to the type of surroundings.

#### **BIKE TRAIL:**

Need to address the marking on the roadway or the bike trail and the signs. The widening of the bike path and or roadway is also an issue.

#### COMMUNITY PARK:

No information to report on this park currently.

stated we need to know where they need to go and what they need to say.

Commissioner Breen suggested they all be designed and to look the same

Commissioner Wayson stated the need for signs at Brookwood and Pecan; Lakeview and Pecan Wendy Wayson as a citizen stated she would donate one sign.

Chair Whitis suggested a sign at the main entrance and then directional thru the city.

Some of the volunteers will get together and design and bring their recommendations back to the next meeting.
