THE CITY SHALL NOT BE OBLIGATED UNDER THIS AGREEMENT TO FURNISH ANY SERVICE OF A TYPE OR CHARACTER NOT AVAILABLE FROM THE EXISTING LINES OR FACILITIES.

THE CONSUMER AGREES TO PERMIT THE AUTHORIZED AGENTS OF THE CITY FREE ACCESS TO THE PREMISES OF THE CONSUMER FOR THE PURPOSE OF CONNECTING, DISCONNECTING, INSPECTING, TESTING, READING METERS, REPAIRING OR REMOVING ANY PROPERTY OF THE CITY AND AGREES NOT TO PERMIT ANYONE OTHER THAN AUTHORIZED AGENTS OF THE CITY TO MOLEST OR OTHERWISE TAMPER WITH THE PROPERTY OF THE CITY TO REMOVE ITS SEALS.

THE CITY WILL MAKE REASONABLE PROVISIONS TO INSURE SATISFACTORY AND CONTINUOUS SERVICE, BUYT IT DOES NOT GUARANTEE CONTINUOUS, AND WILL NOT BE LIABLE FOR LOSS OR DAMAGE CAUSED BY ACCIDENTS OR CONDITIONS WHICH IT COULD NOT HAVE FORESEEN OR OVER WHICH IT HAS NO CONTROL. THE CONSUMER AGREES THAT THIS APPLICATION AND AGREEMENT IS SUBJECT TO ALL CITY ORDINANCES AND REGULATIONS COVERING THIS SERVICE MENTIONED, AND THAT SUCH ORDINANCES AND REGULATIONS ARE PART OF THIS AGREEMENT.
